




The T.V. is a tangible object, and those who stream the data across the airwaves are tangible objects.

The Note mysteriously becomes an Intangible object. It is then called an eNote to allude those into believing it is the real deal.

When you touch the display screen, you see what appears to be tangible objects within the viewing area of the display screen, but you cannot touch those tangible objects. Only the physical parts of the display screen can you touch.






The eNote is an Intangible object.

But wait! 15 U.S.C. 7003 says certain items governed by the UCC are excluded from eSign. Article 3 belongs to the Uniform Commercial Code.

Governed by Article 9, Uniform Commercial Code. Article 9 does govern intangibles as they are a sale of goods. But the Deed of Trust lien is not governed by Article 9.
